#### 10. Change of rule 7.1 from the Constitution:

Peter Noden explained that the post of Team Director was problematic. He had looked at the description of the role and realised that it is a liaison role with UK Deaf Sport, not that of a "Second Chairman". He proposed a change so that the role should be called "UKDS Liaison Officer".

Also, with regard to the Head Coach, he had realised that although the post was a nominated one it doesn't have a vote, which he felt was crucial for a professional role. Brian Baxter proposed that the 2 changes should be accepted, and Alison Saines seconded that.

#### 11. Forthcoming events and dates:

A discussion was had about the international short course competition which is to be held in Rochester, USA on 9<sup>th</sup> January 2014. Were we sending a team or was it up to individuals to enter? Angela Holmes suggested emailing members to gauge interest, but that the 2014 European Championships were the priority for the club. Jane Cranford asked whether the event was an open one? The answer was yes: Lillian Walkup asked about the size of the team to be taken to the European Championships: was it to be bigger than that going to the Deaflympics 2013? Angela Holmes said yes, it was. She said that the European championships were to be held in Siberia, but that we needed to know more about it.

#### 12. Any other AGM business:

• Martin Lee talked about his ongoing project to design a lighting system that would be suitable for deaf swimmers. His role was to design hardware, and an engineer was working on the software. It was to be a portable system, for use at mainstream as well as deaf events. The final costs would depend on the costs of software, and he would bring a prototype along when available. Jim Joyce asked whether the system would need to be licenced or verified for records purposes. Margaret Baxter asked who would own these systems? Martin said that he felt the swimmers could buy their own, and the club could possibly purchase a set too. It was proposed that the

system would also, as well as acting as a starter, be capable of flashing for a false start as well as the rope being dropped.

However, if anyone else is willing to attend please let me know, as the first meeting is set up for July 2013.

However, he did point out that he could not commit either way at this stage and for me to speak to him in October 2013 regarding this.

#### Coach report 2013

It has been a quiet year, for the GB Deaf swimmers, due to no major international Deaf events taking place.

There was a good turnout at Liverpool Training Camp last December with 19 swimmers attending. Thanks to Tracey Nisted and the committee members, for organising this.

On 17/18<sup>th</sup> November, nine Deaf Swimmers competed at Luton Town Inaugural Long Course Meet 2012, where they gained a valuable experience and competed at a higher level, which all disabled swimmers were able to compete in a full swimming programme in a LC pool, which they lack experience of. It's a good opportunity for the coaching team to assess the swimmers' performance. There were 24pbs out of 39 events by swimmers, with Caira Tappenden gaining five British 11u records. Had several enquiries from other coaches on Deaf swimming, and certainly it raised Deaf Swimming profile. The officials totally respected Deaf Swimmers, especially at the start. Even the organiser placed the GBDS Team next to the fire exit door!

17 Deaf swimmers competed in the DSE in November 2012, this is the highest number we have ever seen. There were 25 Deaf records, including 3 British Records, by Jack McComish (2) and Lucy Walkup.

In March 2013, Junior DSE event was held, where 13 Deaf swimmers competed in 89 events, and achieved 67 PBs between them. Danielle broke 5 British records and Lucy Walkup broke her own record in 100m Breaststroke event.

Only 5 Deaf swimmers competed at British International Disability Swimming Championship in April 2013, as the organisation stated S15 weren't allowed to be in the finals, which caused several swimmers refusing to enter, due to discrimination. Though after the first day morning heats, Deaf swimmers found out they are in the finals! It was such a shambles!

Last summer, it was announced by ICDS that Deaflympic confirmed to be held in Sofia, Bulgaria in July 2013. Ten GB Deaf swimmers have been selected, though I am really gutted that 3 medal potential swimmers are unable to compete, which will put GB in the medal position lower than expectation, as we need to keep GB on the map.

Thanks to the committee members who are heavily involved in GB Deaf swimming.
